This has reference to the proposal submitted by Chandigarh Engineering College, CGC Landran Mohali, Kharar Banur Highway, Sector 112, Greater Mohali, Punjab 140307 for conferment of autonomous status.

The Commission in its meeting held on 23.12.2024 has approved the recommendation of the Standing Committee on Autonomous Colleges to confer the autonomous status to Chandigarh Engineering College, CGC Landran Mohali, Kharar Banur Highway, Sector 112, Greater Mohali, Punjab 140307 affiliated to I. K.
